Transit Infrastructure Fund Annual Report – Round 4 (2024)

Round 4 (2024) Update

The Metro Transit Infrastructure Fund program remains successful based on the continued participation of many jurisdictions. A call for Round 4 projects was published on March 1, 2024, and by the May 31st deadline, 39 applications were submitted. These applications were submitted by the following 25 jurisdictions (some submitting more than one application):

After all projects were scored, the City of Cincinnati was informed they are only eligible for \$1,500,000 for their Ridge Avenue Rehabilitation project per the Eligibility Guidelines.

"No single applicant may be awarded more than 50% of a program year's total funding."

Total funds awarded for Year 4 are \$19,412,888 in addition to the committed \$14.5 million for Western Hills Viaduct. The final step of approving awards was completed in August 2024 when the Integrating Committee gave their approval of the recommended projects and their contracts.





Board Discussion – Program Review and Considerations

MTIF Program Funding. It is likely that the program will experience funding challenges like the 2024 program year until the completion of the Western Hills Viaduct. Assume \$30 million funding per year, \$14.5 million assigned to Western Hills Viaduct, leaves \$15 million per year for projects. This equation is critically related to the direction of the program and considered by the staff when developing recommendations to improve the program.

Additionally, staff reviewed the original issue 7 ballot language below for consideration of proposed improvements.

The Southwest Ohio Regional Transit Authority (SORTA) proposes to levy a sales and use tax in the amount of eight—tenths of one percent for a period of twenty-five years. Twenty-five percent of the proceeds of the levy shall be used for public infrastructure projects, like building or maintaining roads or bridges; and seventy-five percent of the proceeds shall provide general revenues for operating the Metro transportation system. None of the levy money shall be used for the Cincinnati Streetcar. If this tax is approved, the City of Cincinnati earnings tax will be reduced by three-tenths of one percent according to the City's Charter.

Potential Long-Term Program Improvements. The staff recommends changing the structure of the program, to include following concepts.

- Ability to Proceed, per the guidelines, "Will construction be underway within one (1) year
 from date of funding award unless otherwise approved?": In many cases applicants' projects
 are contingent upon receiving MTIF funds. 1 year from award does not allow for enough time to
 complete the preconstruction activities.
 - Staff recommends revising the Ability to Proceed requirement from 1 year to 18 months.
- Economic Growth Criteria, per the application guidelines, "Provide a statement detailing how the project will enhance economic growth. It is highly recommended to include how it will help transit service to provide access to employment, residential or commercial developments.": The applications are shallow in documentation that demonstrates the viability of the project and its impact on economic growth. We do not have a scoring criterion for community impact. Projects may not be able to directly demonstrate economic growth but may be aligned with a community project in which an applicant can provide supporting plans and justification. This would allow for the consideration of improvements to infrastructure projects that have adjacent parks, recreation centers, wellness centers, and other community complexes. Improving the infrastructure to include accessibility and safety that aligns with community plans indirectly supports economic growth.
 - Staff recommends revising the criteria to include considerations of community impact.



- Online digital tool for receiving program applications and grant administration
 - During our October 10th program feedback meeting with municipalities this was a consensus request from those in attendance.
 - Staff recommends investing in an online software tool to facilitate the MTIF program.
- Divide project awards into a large and small project category
 - o Staff recommends revising the program to include large and small funding categories.
 - Split the total available funds into two funding categories. Recommended split, 67% large project pool and 33% small project pool. Projects will be divided into funding pools based on their grant request amount. Grant request amounts greater than \$1M will be scored amongst the large project pool and grant request amounts less than \$1M will be scored in the small project pool. See example on the next page.






